

# North Okanagan Senior Boys “A” and “AA” Soccer League 2025

**“A” Schools:** King’s Christian, Revelstoke, Vernon Christian

**“AA” Schools:** Jackson, Kalamalka, Pleasant Valley, SAS, Seaton,

**Exhibition Schools:** George Elliot, Vernon Secondary

- Games are on Mondays and Wednesdays
- Due to the extremely short season and crossover league composition:
  - “AA” teams play each other once, and playoffs (top 4 teams in playoffs)
  - “A” teams play each other twice, no playoffs, league play decides rankings
  - “AA” teams will play one “A”/exhib team
  - “A” teams play one-two “AA”/exhib team
- Team listed SECOND is the HOME TEAM.
- Kick off at **3:30pm**, 35-minute halves
  - If home teams are not able to start at 3:30pm due to field restrictions: your AD/coach MUST email or phone the other team’s AD/coach TWO DAYS in advance to tell them of the alternate start time. Guest team may request a later start, but please recognized that the home team may not be able to accommodate you.
  - Home teams must advise visiting teams of game field location at least 24 hours in advance of the game (email or phone)
  - If a travelling team is going to be late, the coach MUST call the home school as soon as they realize this (maximum late game start is 4:00pm WITH a phone call or travelling team forfeits game and pays ref & field fees if necessary to host school.)
- Accredited referee required (may **not** be coach/asst coach of either school), and if possible, two knowledgeable ARs, (may not be members of either team – communicate with ref and other team as to if you have ARs → perhaps you’ll agree to settle for knowledgeable parents/spectators)
- Three points for a win, one point each for a tie (no OT or shootouts during league games)
- For “A” placings, only games against the “A” schools are counted.
- For “AA” placings, only games against the “AA” schools are counted.

**\*\* Home teams MUST report scores by noon the following day** (even if it is an exhibition game) – email [margotd@kingschristianschool.com](mailto:margotd@kingschristianschool.com)

- both “A” Zone Champion and “AA” Zone Champion will be decided in two playoff games (split ref costs, higher ranked team hosts). In case of tie for points for rankings, the game score differentials per game will be looked at to determine placings before playoffs.

## • **Zone Playoff games are Valley Playoff format:**

- Length of games is 35-minute halves for all games.
- Substitutions are unlimited
- Ties: (a) Golden Goal rule applies to overtime: 2 x 10 minute halves  
*if still tied then:*
  - (b) 5 penalty shots per team by 5 different players, and if still tied, then penalty shots until a winner is determined
